We have read through the report by Frans Prins and note that members of the community have ruled out presence of graves in the development footprint. The developer is advised to have evidence of public participation relating to possibility of graves around the general landscape . This should take the form of wider community participation . The abandoned homestead cultural landscape and features should be mapped out and a register of all that were interviewed around the graves issue should form part of the HIA report as abandoned homesteads have yielded previously unknown graves resulting in work stoppage and unnecessary delay.

However Amafa requires a field-based paleontological survey to be conducted before final decision on this application can be reached.
