## **Interim Comment**

In terms of Section 38(8) of the National Heritage Resources Act (Act 25 of 1999)

Attention: Gamawela Communal Property Association

It is proposed that the two existing, damaged low-water bridges on Portion 1 of the farm St. George 2-JT near Gamawela Village be upgraded. Parts of the existing crossings were destroyed by floods in 2010, and during times of heavy flow in the Klein Dwars River and its tributaries, the crossings become impassable to local community members.

Under sections 34, 35 and 36 of the National Heritage Resources Act (25 of 1999), heritage resources are protected. These resources are for instance burial grounds, unmarked and marked graves that are older than 60 years, built structures that are older than 60 years old, archaeology (stone tools, stone walled sites, prehistoric and historic pottery sherds, ash grounds etc.) and palaeontology (fossils of plant and animal material).

SHASA Heritage Consultants cc was appointed by Polygon Environmental Planning to conduct a Heritage Impact Assessment for the proposed upgrading of an existing low-level bridge. The bridge is located in Ga-Mawela Village on the farm George 2 JT near the town of Steelpoort Limpopo Province.
