ALTERATIONS AND ADDITIONS TO EXISTING HOUSE FOR NEW MULTI-STOREY RESIDENTIAL ACCOMMODATION ON PORTION 11 OF 1 OF ERF 6768 DURBAN, 28 SHESTNUT ROAD, GLENWOOD, DURBAN, ETHEKWINI, KWAZULU-NATAL. DRAWING 6707/22 1&2

The Heritage Officers Committee meeting considered your application on 29 November 2022. The committee was unable to arrive at a final decision based on the lack of adequate pictures with context for assessment. The following are required for further consideration:

- 1. Photographs of all sides of the building and they must provide context in terms of in which side the photographer is capturing from.
- 2. A photograph indicating where the staircase is proposed.
- 3. The proposal and design of the building must take cues from the streetscape and the neighboring properties.
- 4. The floors must be suspended concrete floors.

Furthermore, the committee noted that there is a timber deck that was not approved, therefore, a form I application is required or proof that the deck was added to the property before it reached the 60 years mark.

Failure to comply with the requirements of the National Heritage Resources Act and the KwaZulu-Natal Amafa and Research Institute Act could lead to legal action being constituted against the applicant.
