PGS Heritage (Pty) Ltd (PGS) was appointed by Zitholele Consulting (Pty) Ltd (Zitholele) on behalf of South African National Roads Agency SOC Limited (SANRAL) to undertake an Environmental Authorisation (EA) Application for to upgrade National Road R54, Section 1, stretching from Potchefstroom to the former Northwest/Gauteng provincial border, Gauteng Province and Northwest Province.

The strategic infrastructure initiative prioritizes the incorporation of Non-Motorized Transport (NMT) facilities and enhancements to public transit services to ensure safer and more inclusive mobility. The project objectives are to improve road safety for both vehicles and pedestrians, support surrounding community development, and modernize existing infrastructure to meet future demands. Planned upgrades include road widening to increase capacity and accommodate all road users, new pavement construction for improved ride quality and durability, and enhanced drainage systems to prevent flooding and structural degradation

Project structures will be redesigned to meet updated hydraulic and structural requirements aligned with the new road geometry. These structures will be replaced and upgraded, including approximately 112 minor culverts, four major culverts, and five bridges. To support construction activities, five borrow pits have been identified. The anticipated material requirements include approximately 480,000 m³ of G6–G8 materials from five sources, 500,000 m³ of G5 materials from three sources.

In terms of palaeontological sensitivity, the site is located on unknown to very high palaeontological sensitivity area According to the SAHRA palaeontological sensitivity map and the likelihood of fossil materials being uncovered in this project area is likely.

Angel, J. October 2024. Heritage Impact Assessment for proposed Improvement on National Road R54 Section 1 From Potchefstroom (km 0.0) To Previous NW/GP Border (km 41.60). North West Province.

No heritage resources identified within the development footprint and within the surrounding area, the proposed development will not have a negative impact on the heritage resources.

Chance Finds Procedure is recommended and must be implemented.

Butler, E. October 2024. Palaeontological Impact Assessment for the proposed R54 Road Upgrade (section 1 from Potchefstroom (km 0.0) to previous NW/GP border (km 41.60) in Gauteng Province and in North West Province.

No fossiliferous outcrop was detected during the site investigation; fossil heritage of scientific and conservational interest is relatively rare in the development area. A High Palaeontological Significance has been allocated for the construction phase of the R54 road upgrade Project pre-mitigation and a Low significance post mitigation. No significant impacts are expected to impact the Operational and Decommissioning phases; the Cumulative impact of the development is medium pre-mitigation and Low post mitigation and falls within the acceptable limits for the project. The development may thus be permitted in its whole extent, as the development footprint is not considered sensitive in terms of palaeontological resources.

- No further palaeontological heritage studies recommended.
- Chance Finds Procedure is recommended and must be implemented.

 inspect the heritage resource. If the newly discovered heritage resources prove to be of archaeological
 or palaeontological significance, a Phase 2 rescue operation may be required subject to permits issued
 by SAHRA;
- The Final BAR must be submitted to the SAHRIS application for record purposes;
- The decision regarding the EA application must be submitted to the SAHRIS application for record purposes.


