Dear Applicant,

This serves to inform you that Permit ID 4659 is hereby cancelled in terms of Regulation 4(3), Chapter II of the National Heritage Resources Regulations No. 21239 of June 2000 due to non-compliance with permit condition no. 10, stating that:

[10] Proof of notification and signed receipt of the notification of the granting of the permit by the consenting families must be submitted to SAHRA within 14 days of issuing the permit. Should this not occur, the permit will be cancelled due to non-compliance with permit conditions.

Upon SAHRA informing the applicant to submit proof of compliance with condition 10 of Permit ID 4659, on the 14th day of permit issuance, the permit holder informed SAHRA that no action had been taken to comply within the timeframes indicated by the above condition. Notifications were sent on the 21st July (after the timeframes indicated in the above condition) to the consenting families, however this does not satisfy the need for signed receipt of the notifications.

In the event that the Applicant objects to this cancellation, an appeal may be lodged with the SAHRA Council within 14 (fourteen) calendar days of this Notice in accordance with Regulation 7 of the National Heritage Resources Act Regulations No. 21051 of April 2000.
