Eskom Holdings SOC Ltd, Limpopo Operating Unit (LOU) intends to construct the power line for the L920883797 Project. The power line will include new 0.484km which will T-off from the existing power line in pole number RGB252/89A/26/11 (refer to the Span plan sheets and the Pegging Coordinates for more information) traversing on portion 0 of the Farm of Keulen No 669 LT in Greater Tzaneen Local Municipality of Mopani District Municipality of the Limpopo Province.

The proposed power line case does not include ground level photographs. The SAHRA cannot make a decision on potential impacts to heritage resources the power line may have without the submission of ground level photographs.

Interim Comment

This application constitutes a section 38 (1) application for approval by SAHRA in terms of the National Heritage Resources Act, no 25 of 1999 (NHRA), as the proposed power line exceeds 300 metres in length. As such SAHRA is providing response in terms of section 38(2) with regards to this application.

However, the SAHRA requires additional information to assess the potential impact on heritage resources. Therefore, the SAHRA request for the following to make an informed decision.

- The .kml file and the engineering survey design drawing must accurately reflect the proposed powerline layout.
- Ground level photographs of power line route must uploaded to the case.
