5. The proposed method of mitigation outlined in section 6.2.2 of the permit application document is approved.
6. As per the methodology provided, the excavation area must be rehabilitated.
7. All material collected and excavated, as well as field notes and records, will be curated by the Department of Anthropology and Archaeology, University of Pretoria, who will be responsible for the permanent curation and safekeeping of all artefactual material in a condition that allows for ongoing research.

SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory. No information protected by POPIA must be included in the report. If there is a delay in submitting the report, SAHRA must be informed in writing.**
10. **This permit is subject to a general appeal and may be suspended should an appeal against the decisions be received by SAHRA within 14 days from the date of the permit. SAHRA may not be held responsible for any costs or losses incurred in the event of the suspension or retraction of this permit.**
11. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with the heritage authority.
12. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
13. Request to renew permits must be done at least two months prior to the expiry of the existing permit.
14. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
15. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of the heritage authority and the landowner.
