### EXHUMATION AND RE-INTERMENT OF THE REMAINS OF TLADI KGOTLE IN TERMS OF SECTION 36(3) OF THE NATIONAL HERITAGE RESOURCES ACT (NHRA 25 of 1999).

The remains of Tladi Kgotle were buried in 1947. It is therefore protected by the NHRA and characterised as heritage resources due to the age of the remains. The grave is currently buried at **Keikelame Farm, in Thaba Nchu** and the family have requested for the remains to be exhumed for reinternment at **Reitfontein Trust Cemetery, Thaba Nchu**. The **Ponelopele Tombstones & Funeral Services** have been appointed to conduct the exhumation and reburial. SAHRA has no objection to the proposed exhumation and re-internment activities. The following conditions must be adhered to.

#### Conditions:

1. The family representatives must be on site when the exhumation and re-internment take place.
2. Human remains must at all times be handled with respect and graves should not be disturbed except where unavoidable.
3. The consultation procedure as indicated in the NHRA Regulations of 2000 and the National Heritage Resources Act no 25 of 1999 must be observed.
4. SAHRA must be notified of the completion of the exhumation and re-internment in writing.
5. It is the responsibility of the family to obtain permission from the landowner for each visit to the site.
6. Conditions of access imposed by the landowner must be observed.
