- 10. If human remains are uncovered during the test, all activities must stop and public consultation must begin to identify the next-of-kin. A formal grave relocation process will commence if required, then a permit in terms of section 36 of the NHRA must be applied for from SAHRA on SAHRIS.
- 11. A final report on the results of the test excavation must be submitted to the heritage authority issuing this permit before **7 August 2026**, and must be submitted to the case, using the template in the following link: <a href="https://sahris.sahra.org.za/content/apmpermitreports">https://sahris.sahra.org.za/content/apmpermitreports</a>. Additionally, the results of the test excavation must be included in the HIA for the proposed development. SAHRA reserves the right to withhold further permits if progress is not deemed satisfactory. No information protected by POPIA must be included in the report. If there is a delay in submitting the report, SAHRA must be informed in writing.
- 12. Reprints of all published papers or copies of theses and/or reports resulting from this work must be lodged with the heritage authority.
- 13. This permit is subject to a general appeal and may be suspended should an appeal against the decisions be received by SAHRA within 14 days from the date of the permit. SAHRA may not be held responsible for any costs or losses incurred in the event of the suspension or retraction of this permit.
- 14. If a published report has not appeared within three years of the lapsing of this permit, the report required in terms of the permit will be made available to researchers on request.
- 15. It is the responsibility of the permit holder to obtain permission from the landowner for each visit, and conditions of access imposed by the landowner must be observed.
- 16. It is the responsibility of the permit holder to fill in excavations and protect sites during and after excavation to the satisfaction of the heritage authority and the landowner.


